Tuition Agreement

This shall serve as a summary and notification of your total family tuition obligation for the upcoming school year. It is understood that all payments of said obligation are to be paid in full and on time according to the deadlines specified below. Failure to do so will result in additional late fees automatically applied to your account and notation of your account as delinquent. Penalties incurred during the school year will be added to your FACTS account. Services provided by school include, but are not limited to, in-person classes, as well as, remote learning classes.

1. All tuition payments must be processed through FACTS Tuition Management via automatic electronic funds transfer.
2. Payments must be paid through an approved payment plan set-up to withdraw funds on a predetermined date each month, with the final payment ending on or before June 20th (**no invoices will be issued**). **Please Note:** All 8th grade tuitions must be paid by May 20th.

Approved payment plans are as follows:

Paid in full by August 1st

Quarterly Payments – July, October, January, April

Monthly payments – July – June

Bi-Weekly Payments - July - June

3. If a payment does not clear on the predetermined date, for any reason, a return fee of \$30 will be charged to your account by FACTS. The unpaid tuition will be deemed delinquent and educational services may be suspended until the delinquent account has been rectified.
4. If a student withdraws from school for any reason (moving, expulsion, etc.), financial responsibility will be based on services rendered (any part of a month will be considered as a full month of service).
5. Tuition obligation must be met for the current school year in order to ensure re-enrollment for the following school year.
6. Delinquent tuitions are subject to collection by a third-party attorney and any and all legal fees and collection cost associated with such actions will be the responsibility of the delinquent party.
7. **Your finalized Tuition Obligation including financial aid and discounts can be found in your FACTS account.**

ALL PAYMENT PLANS MUST BE SET-UP VIA FACTS TUITION MANAGEMENT. YOUR CHILD MAY NOT START SCHOOL UNTIL THE PAYMENT PLAN IS IN PLACE. PLEASE KEEP A COPY OF THIS AGREEMENT FOR YOUR RECORDS.

I/We understand that my child's or children's ENROLLMENT AT EAST BOSTON CENTRAL CATHOLIC SCHOOL CONSTITUTES ACCEPTANCE OF THIS TUITION AGREEMENT. Therefore, I/we agree to the requirements for the current school year and accept all provisions of the East Boston Central Catholic School Tuition Agreement and acknowledge East Boston Central Catholic School has the right to collect this debt in the event of default on this agreement. I/We certify that everything stated in this Agreement and all other applications and filings with East Boston Central Catholic School is correct. I/We understand that East Boston Central Catholic School may report any delinquency to my credit history. I/We understand that I/we must update credit and financial information to East Boston Central Catholic School if any credit or financial condition changes.
